Strategic intelligence is intelligence activity used to obtain information about the strategic potential and strategic intentions of a state, organization or other social community that influences the development of a strategy.

This is the highest form of intelligence activity, and its effectiveness depends on the viability of the state or organization that carries it out. Intelligence at the strategic level determines goals and objectives, searches, extracts and processes data, identifies its most important or strategic components, leaving out the most important ones, and presents the results to the highest political and military leadership of a state or organization.

Sources of strategic intelligence information

Sources of strategic intelligence information can contain open and closed information.

The types of data used in strategic intelligence:

➤ Scientific information - information on the achievements of science, health, scientific personnel and their training, the ability of science to contribute to the development of production and research work.

➤ Geographic information, including topography, weather, climate, hydrography, and oceanography.

➤ Information about communications; Strategic logistics: information on communication routes, traffic flows, roads, bridges, tunnels, mountain passes, straits and others, points of departure and arrival, centralized points - places of congestion and intersection of transport routes, coordination and distribution centers.

➤ Economic data, including information on industry, finance, employed and unemployed labor force, etc.

➤ Military information.

➤ Sociological data, including information about the population, religion, education, national traditions and folk spirituality.

➤ Political information, including information about the government system, political parties, foreign policy, etc.

➤ Information about politicians and influential leaders in the country, opposition leaders, etc.

Forms of Strategic Intelligence Activities

Historically, there have been two forms of strategic intelligence activities:

➤ authoritative or lawful intelligence authorized by the authority

➤ Confidential or unlawful intelligence that is prohibited by law

Legal Strategic Intelligence

Legal strategic intelligence is carried out officially, on the basis of national, international legislation or bilateral agreements between states or organizations.

These legal strategic intelligence activities include:

- Diplomat Intelligence
- military diplomatic intelligence
- Scientific research activities
- journalism
- Cultural representations in foreign countries
- Religious organizations Missionary activity
- Trips and expeditions to foreign countries
- Humanitarian missions

Unlawful or Covert Strategic Intelligence

Unlawful or covert strategic intelligence is an illegal activity carried out in violation of national international law. Illegal strategic intelligence is legitimately suppressed by counterintelligence agencies. Unlawful intelligence is a criminal offence and persons who carry it out must be identified, arrested, investigated and convicted of their illegal activities in accordance with national/international law. In the presence of a legally justified evidence base, the search for persons engaged in illegal intelligence activities is carried out by Interpol.

Black office service

Throughout history, there have been special agencies that are responsible for intercepting, reviewing, seizing, or copying mail and, if it contains an encrypted message, decrypting it. Information at the strategic level was immediately conveyed to the top political and military leadership of the state. The Black Cabinet is thought to have originated in France as a secret public service in the 17th century. Later, similar services began to work in other countries.

Interception and review of mail correspondence led to the encryption of messages, and in response, a professional state decryption service appeared in Black Office employees. This, in turn, led to the creation of government structures that were professionally engaged in the creation of methods and means of encrypting and transmitting information of various volumes, involving specialists in various fields of science.

Counterintelligence activities

Some data at the strategic level is a state secret and must be legally protected and protected from aggression by foreign countries, third-party interested organizations and individuals.

The suppression of illegal intelligence activities is carried out by counterintelligence agencies.
